



Membership Agreement

It is agreed that _____ hereinafter referred to as **Coalition Member (CM)**, located at _____, contracts with **National Coalition of Healthcare Recruiters** hereinafter referred to as the **NCHCR** located at 1742 N. Willow Woods Dr. Apt D., Anaheim, CA, 92807 to be a member of **NCHCR**.

1. Responsibilities of Parties:

NCHCR

- Agrees to operate and maintain a proprietary job board referred to as “the site”, which enables the CM to post their proprietary job opportunities on the job board.
- Enhance the site making it continuously relevant to the physician community and recruiting community.
- Agrees to assist the CM in the operation of the site.
- Agrees to promote/advertise NCHCR and the site in national publications and Internet media.
- Agrees to set up a co-op direct mail program.
- Agrees to work with and collaborate with all members to create value added services that bring professional and financial growth to members.
- Plan and execute an annual NCHCR meeting.
- Represent the NCHCR in good faith and act according to the vision and mission.

The Coalition Member

- Be active in the membership and assist in the development of the coalition.
- Take advantage of the value added programs that are created.
- Agrees to post their jobs and/or candidates on the site.
- Agrees to pay monthly dues of \$100 at the beginning of each month (5 employee pass words.)
- Agrees that all splits with other CMs will be on a 50/50 or 20/80 basis.
- Agrees to work in concert with NCHCR efforts and support all marketing initiatives.
- Represent the NCHCR in good faith and act according to the vision and mission.

2. Indemnification: Each party agrees to indemnify and hold the other party (and its affiliates, consultants, attorneys and advisors) harmless against any loss, cost, suit, claim, action, cause of action, damage, obligation, contract, demand, liability, judgment, verdict, settlement or expense (including reasonable attorneys' and other consultancy fees and court costs) arising out of any act or omission of the indemnifying party, its employees, agents or affiliates that occurs in connection with this Agreement and all related Transaction Documents.

3. Terms of the Agreement: This Agreement becomes effective upon written acceptance by both parties and shall remain in force on a quarterly renewable basis. Either party has the right to terminate this Agreement for any reason prior to term expiration given thirty days written notice.
